Current Status	- Centralized C&D Waste Processing Plant Jaipur is under the administrative control of Nagar Nigam Jaipur Heritage. - Nagar Nigam Jaipur Heritage had appointed M/s. PDCOR Limited (an ISO 9001:2015 certified Company) as an Independent Engineer or Third Party Agency for supervision and monitoring of the plant, which is jointly promoted by the Government of Rajasthan (GoR) and Infrastructure Leasing & Financial Services Limited (IL&FS). - List of machineries deployed at Centralized C&D Waste Processing plant are as follows:- Hopper, Grizzly Feeder, Jaw Crusher, Granulator, Screen And Conveyors - Centralized C&D Waste Processing Plant is operational since 1st November 2024. - Firm is collecting the C&D waste through Dumper, JCB and Tractor Trolley which is being transported to Centralized C&D Waste Processing plant for processing. - Upto August 2025, a total of 46048.86 Tons of C&D waste is being collected, out of which 25667 Tons of C&D waste is being processed. - Recycled products like Recycled Aggregate, Interlocking Paver Block made out of Recycled Aggregates and Concrete Brick (Recycled Aggregates) of different sizes and thickness are made at the C&D Waste Recycling Plant. - Firm is directed for testing of recycled products as per standard norms and specification from MNIT, Jaipur, which is under process. - Notification is being published on dated 01.10.2024 regarding notified C&D Waste User Charges. - Dedicated Toll Free No. 18001806681 and 0141-2747400 is created for picking up of C&D waste.
