#### **Public Notification**

The Government has notified Construction & Demolition Waste Management Rules, 2016 for the first time. "Construction and Demolition waste" means waste from building materials, debris and such rubble resulting from construction, remodeling, repair and demolition operations; At present, the construction & demolition waste generated is about 300 TPD in Jaipur. Construction & demolition waste is not a waste, but a resource. The basis of these Rules is to recover, recycle and reuse the waste generated through construction and demolition.

The salient features of the Construction & Demolition Waste Management Rules, 2016 are:

- Applies to everyone who generates construction and demolition waste.
- The generator shall ensure that other waste (such as solid waste) does not get mixed with this waste
  and is stored and disposed separately.
- Every waste generator shall keep the construction and demolition waste within the premise or get the
  waste deposited at collection centre so made by the local body or handover it to the authorized
  processing facilities of construction and demolition waste;
- Waste generator shall ensure that there is no littering or deposition so as to prevent obstruction to the traffic or the public or drains.
- Large generators (who generate more than 20 tons or more in one day or 300 tons per project in a
  month) shall submit waste management plan and get appropriate approvals from the local authority
  before starting construction or demolition or remodeling work.
- Large generators shall segregate the waste into four streams such as concrete, soil, steel, wood and plastics, bricks and mortar.
- Every waste generator shall pay relevant charges for collection, transportation, processing and disposal as notified by the concerned authorities; Waste generators who generate more than 20 tons or more in one day or 300 tons per project in a month shall have to pay for the processing and disposal of construction and demolition waste generated by them, apart from the payment for storage, collection and transportation.
- Procurement of materials made from construction and demolition waste shall be made mandatory to a certain percentage (say 10-20%) in municipal and Government contracts subject to strict quality control.

### For Management of Construction and Demolition waste in Jaipur City

- > Construction and Demolition waste shall be stored and delivered separately at such spot and at such time as notified by Nagar Nigam Jaipur or its agent from time to time for collection of such waste.
- For Generators shall be responsible to segregate the construction & demolition waste at source and may transport to designated place in the ward/zone or may contact a local help-line of Nagar Nigam Jaipur i.e. +91-141-2747400.
- Nagar Nigam Jaipur shall then send a vehicle to pick up such segregated construction & demolition wastes on payment of necessary charges in accordance to the services sought by the said generator and transport this waste.
- The details of local Help line of Nagar Nigam Jaipur/designated place/collection centre shall be available in the respective Ward Offices of the Municipal Corporation of Nagar Nigam Jaipur or on <a href="http://jaipurmc.org">http://jaipurmc.org</a>.

Nagar Nigam Jaipur hereby mandates to follow the above directions which is essential as per the Construction and Demolition Waste Management Rules, 2016, citizens are requested to join hand with Nagar Nigam Jaipur.
